During March, 2005 the recovery of toll tax by CB's Bahawalpur & Okara was barred vide GHQ, QMG's Branch letter No. 48/65/05/Q-Coord dated 28.03.2005 whereafter, the revenue generation capacity got devastating effects and resultantly, the span of development program was quenched to a considerable extent which marred the outlook of the locality.
- (iii). The Hon'ble Supreme Court of Pakistan, vide its judgement dated 15.03.1986 in a Civil Appeal No. 86 of 1974 titled as Goldern Roadways Transport Bus Company Vs. the Executive Officer, CB Okara held that CBO is authorized to collect this tax within its area of jurisdiction.

It is pertinent to mention here that the contractor won the contract of Hafta Bazaar in open public auction and signed agreement as per terms and conditions of the contract duly approved by the DML&C, Multan Region.

Moreover, as per condition No. 18 of the approved terms and conditions for the contract, the Cantonment Board would not be responsible for any loss to the contractor under any circumstances. On the other hand, if resorted to the 3<sup>rd</sup> option i.e. termination of contract, the Board may be deprived of a handsome amount worth Rs. 1.74 (M) as the re-auction may not fetch that handsome amount because the contractor won the contractor during a cut throat competition under special circumstances, which may not recur again.

Application along with relevant file is put up for consideration of the Board and deciding further way out.

**RESOLUTION:** Considered and discussed at length. There was a unanimity of views, amongst the members present, that the contractor be bailed out as he is undergoing loss under the prevailing circumstances, thus, he be allowed to hold hafta bazaar twice a week.
