4. REVENUE BRANCH: CANCELLATION OF BOOKING OFFICE CONTRACT AND BLACK LISTING OF CONTRACT FOR AWARD OF FUTURE CONTRACTS.

Reference CBR NO. 20 dated 12-04-2019

To reconsider the above mentioned CBR in the light of recent events held after 12-04-2019 and to decide the fate of the contract of Booking Office.

It is apprised that the Honourable Lahore High Court has directed the Contractor of Booking Office to avail proper remedy as mentioned in the contact agreement and disposed of W.P. No. 9728/2019 on 30.05. 2019.

Meanwhile, the Contractor has filed the case in the court of Arbitrator (Worthy DML&C Multan) while DMLC Multan has asked this office to submit comments on the subject case which have been submitted vide letter no 208/CA/114/OK/2315 dated 10.06.2019. The case is now pending in the court of Arbitrator (Worthy DML&C Multan) for decision.

The Contractor has already challenged the fine of Rs. 50000/- and Rs. 75000/- imposed by this office vide letters no. 208/CA/114/OK/6415 dated 08.03.2019 and No. 208/CA/114/OK/2298 dated03.06.2019 respectively, which has been uphold by the board.

Relevant documents are placed on the table.

RESOLUTION:

Majority of the members in presence agreed with PCB to cancel the agreement considering adequate chances have already been given to contractor but he failed to comply with.

The Board resolved the cancellation of the contract of booking office on following grounds:-

- 1. Illegal collection of fee from Non-AC buses / coaches.
- 2. Overcharging Booking Fee from the bus owners.
- 3. Misbehaving with bus owners / transporters.
- 4. Unauthorizedly using the trade mark of eminent transportation companies.
- 5. Non provision of list of the companies / AC Buses for which he had booked the seats.
- 6. Non provision of list of booking office staff.
- 7. Non depositing of fine Rs.50000/- imposed by the Board vide letter No. 208/CA/114/OK/6415, dated 08.03.2019.
- 8. Non depositing of fine Rs.75000/- imposed by the Board vide letter No. 208/CA/114/OK/2298, dated 03.06.2019.
- Keeping and issuing fake ticket of renowned companies and non provision of Daewoo / Faisal Movers Services.
- 10. Illegal Real Estates Business at Booking Office.
- 11. Non provision of Daewoo / Faisal Movers Services.
- 12. Discontinuation of much needed of Daewoo Bus Service for Cantt Residents, due to his illegal /stubborn behavior with Daewoo which resulted into shifting of Daewoo Terminal to Okara City.
- 13. Failure to bring back Daewoo Bus Services as he gave written undertaking.
- 14. Failure to ensure basic maintenance of booking office which causes great inconvenience to passengers sitting in waiting room.

It is pertinent to be mentioned here that following members voted against the cancellation vide their application dated 17.06.2019:-

- 1. Mr. Muhammad Shahzad Shafi, Vice President
- 2. Mr. Muhammad Akram, Elected Member
- 3. Mr. Tariq Javed, Peasant Member
- 4. Mr. Nadeem Inayat

The contractor was black listed with the majority votes.

In wake of the Board proceeding the Secretary of the Board/CEO submitted a note vis-à-vis a civil case titled Muhammad Asif Yar V/s Cantonment Board Okara etc. wherein it is stated that the Civil Court is seized with the matter and an injunction has been issued as such the worthy PCB advised to expedite the efforts for resolving the matter in the court and also suggested to the Board that the outcome of instant resolution will be translated into action as an aftermath of interim injunction. The Secretary of the Board briefed further that several sections of Cantt Act are repugnant to the suit at hand that there is all likelihood that the Board's version would finally acceded to.
